# Re: Fixed Wireless Communications Coalition and National Spectrum Managers Association, Request for Waiver of Sections 101.31(b)(1)(iii) and 101.147(r) of the Commission's Rules to Promote More Efficient Use of Spectrum (*18 GHz Narrowband Waiver Request*)

Dear Ms. Seidel:

We thank you and your colleagues for meeting with us on November 14 about the abovereferenced waiver request. As you know, the request seeks a blanket waiver to permit the coordination and licensing of Fixed Service licenses in the 18 GHz band at bandwidths of 2.5, 5, 6, 30, and 50 MHz, in addition to the 10, 20, 40, and 80 MHz bandwidths presently allowed. It was filed jointly by the Fixed Wireless Communications Coalition and the National Spectrum Managers Association on May 29, 2002.

At the meeting, I promised to provide the information below.

## 1. Current Narrowband 18 GHz Users

The following table covers 18 GHz users occupying either 5 MHz bandwidths in the 340 MHz split (since reallocated to satellite services) or 10 MHz channels in the 1560 MHz split.<sup>1</sup> Wider bandwidth users are omitted. Comsearch's database shows a breakdown of the links as follows:

15%	CLECs, utilities, public safety, railroads, industrial/business

### 2. **Relocation from 2 GHz**

Approximately 7,200 licensed links in the 2.1 GHz band are subject to potential relocation. The maximum bandwidth of these systems is 3.5 MHz. Many operate in 1.6 MHz bandwidths. Depending on path length, many of these are candidates for narrowband channels at 18 GHz.

### 3. Addition of 6 MHz Channels to Waiver Request

As we indicated previously, the Second Order on Reconsideration in IB Docket No. 98-172 eliminated co-primary Fixed Service at 18.3-18.58 GHz.<sup>2</sup> Most of the affected users are private cable operators delivering analog video in 6 MHz channels. To accommodate these users elsewhere at 18 GHz, we amend the waiver petition to allow coordinators to assign 6 MHz channels (in addition to the 2.5, 5, 30, and 50 MHz previously requested).

#### 4. Interim Waiver

We understand the Bureau is presently considering our waiver request in the context of other issues that may take some time to resolve. We respectfully ask the Bureau to grant the waiver on an interim basis, subject to withdrawal if it is ultimately inconsistent with the resolution of other issues.
